Addendum to MoU Dated 22.02.2019

The following is to be added as part of existing MoU between Anna University (AU) and AICTE entered on 22.02.2019

1. AU, will establish a coordinating Nodal Centre for the purposes of tasks and activities as per the MoU. AU is also tasked for writing / translating books in Tamil as applicable to UG / Polytechnics as per AICTE's model curriculum.
7. AU will nominate a Coordinator, a serving faculty member to take this additional responsibility, for this purpose with the approval of AICTE. The coordinator shall be responsible for efficient management of all activities included in MoU alongwith additional responsibility of "Technical Book Writing" according to terms & condition explained in scheme document (copy enclosed for reference).
2. The coordinator shall be entitled to draw an honorarium of Rs. 10,000.00 per month for the services rendered by him in addition to his regular duties. This amount shall be periodically compensated by AICTE against the claims raised by coordinator and duly forwarded to AICTE by the AU at the end of June/ December months of every calendar year.
